# 2023 Water Main Replacement & **Street Improvement Project**

PROJECT DESCRIPTION: The Village of Wauconda 2023 Water Main Replacement & Street Improvement Project is nearing its completion. The project was split into two separate phases of construction, North and South. The Downtown portion of the South project is substantially complete with work on-going in Hubbard Woods and Kent Avenue areas. The Village and HMG Engineers, Inc. will continue to provide weekly updates as they become available to provide the residents of Wauconda the most up-to-date information available. ## HUBBARD WOODS

#### WHAT TO EXPECT:

Helena Ave: All water main work and water service connections are complete!

George Ave: All water services have been reconnected and water main work will be complete Friday 9/15 -Saturday 9/16.

Orton Ave: Newly found lead services are causing a slight schedule delay. The Village and contractor are working with the affected residents to perform immediate inspections and coordinate replacement. The final water main reconnections cannot occur until all lead services are removed.

**PAVING UPDATE:** The contractor plans to start milling the existing asphalt the week of September 25 and install the first layer of asphalt that same week. There will be a week of utility adjustments before the final surface layer of asphalt will be installed. Weather and lead water service pending, the contractor is planning on substantially completing the project the 3rd week of October.

#### WHAT TO EXPECT (KENT AVE):

All water main installation and testing are complete. Thank you for your patience during the water service interruption to reconfigure the piping. New water service boxes were installed and one house connection was made.

The remaining lead service houses are scheduled for replacement the week of September 25. The existing water main abandonment will occur following the reconnection of all water services.

**PAVING UPDATE:** The contractor plans to start milling the existing asphalt the week of September 25 and install the first layer of asphalt that same week. There will be a week of utility adjustments before the final surface layer of asphalt will be installed. Weather and lead water service pending, the contractor is planning on substantially completing the project the 3rd week of October.
